## Notice of Acquisition of Hotel Zuiho and Akiu Grand Hotel

Belluna Co., Ltd. (the "Company") announces that it has been determined that the Company will acquire two properties in Sendai City, Miyagi, namely Hotel Zuiho and Akiu Grand Hotel, from Karakami HOTELS & RESORTS Co., Ltd.

Although the Timely Disclosure Standards do not apply to this matter, the Company is disclosing it voluntarily because it has determined that it is useful information.

### 1. Reasons for acquisition

The Company defines the property business centering on the hotel business as a growth area where the Company aims to expand profitability in the 6th Short-Term Business Plan. Now set to be acquired by the Company, Hotel Zuiho and Akiu Grand Hotel are both located at Akiu Onsen, a leading hot spa resort in the Tohoku region. These are large resort facilities with high name recognition and capacity to stably attract customers. Going forward, the Company will leverage its accumulated customer base, expertise in hotel operation and recruitment capabilities, seeking to continuously increase profitability and the brand value.

The acquisition of the two hotels will further enrich the Company's hotel portfolio. That will help enable well-balanced business operations in terms of scale and areas of operation. In view of a turnaround in tourism demand and growth in inbound tourist demand, the Company expects to further increase its presence and to maximize revenue opportunities.
