

Consolidated Monthly Sales Growth (year-on-year)

In October, all city hotels in the hotel business exceeded their sales in the same month of the previous year. In particular, a total of three hotels (Ginza and two hotels in Osaka) recorded their highest single-month sales ever. As a result, net sales were 2,537 million yen, up 23% from the same month last year.

In the specialty mail-order business, sales in the cosmetics and health foods segment were 972 million yen, up 2% from the same month last year. In the cosmetics mail-order business, the number of new customers acquired is recovering, significantly exceeding that of the same month last year, and we will continue to work on improving the regular customer retention rate.

As a result, consolidated group sales for October totaled 17,967 million yen, up 1% from the same month last year.
