

Consolidated Monthly Sales Growth (year-on-year)

In April, the Hotel business continued to perform well in general, especially at resort-type hotels in the Hokkaido area. In city hotels in the Kansai area, sales were strong due to the Osaka Kansai Expo and the cherry blossom viewing season in Kyoto. As a result, net sales were 2,001 million yen, up 33% from the same month of the previous year.

In the Apparel & Goods business, there were the effects of curbing the volume of paper publications in order to focus on profitability, a reactionary drop from strong sale sales in the previous month, and the impact of lower sales in the mall business, whose services were terminated at the end of the previous fiscal year. As a result, net sales were 6,376 million yen, down 7% from the same month of the previous year.

As a result, consolidated group sales for April totaled 15,988 million yen, up 0.2% from the same month of the previous year.
